IN 2013, SBNC WAS AWARDED A NEW ACCESS POINT DESIGNATION FROM THE HEALTH RESOURCES AND SERVICES ADMINISTRATION, DESIGNATING THE GOLETA EXPANSION SITE AND SERVICES AS A SECTION 330(E) FEDERALLY QUALIFIED HEALTH CENTER (FQHC) UNDER SECTION 330(E) OF THE PUBLIC HEALTH SERVICE ACT. THE EASTSIDE NEIGHBORHOOD MEDICAL/ EASTSIDE NEIGHBORHOOD FAMILY DENTAL, WESTSIDE NEIGHBORHOOD, AND ISLA VISTA NEIGHBORHOOD CLINICS WERE PREVIOUSLY OPERATED UNDER LOOK ALIKE STATUS WITHIN THE RULES OF AN FQHC, IN CONJUNCTION WITH CODE SECTION 330(E) STANDARDS WERE BROUGHT INTO THE FULL 330(E) SCOPE OF PRACTICE FOR AN FQHC.
